### DATE

Sunday, July 25, 2010, 10 a.m. to 5 p.m. on Main St.,  
Narrowsburg, NY. **Rain or shine.**

### ELIGIBILITY

This is a juried show open to artists, craftspeople and photographers. All work must be original in design and produced by the exhibiting artist. **Not allowed** are objects made from commercial kits or molds or items that are imported or for resale. DVAA reserves the right to reject any booth out of compliance.

### ENTRY REQUIREMENTS

**New this year:** *All* applicants must submit four clear images of your work on a CD (300 dpi) by **May 7**. High quality detailed photographs are also allowed. Only CDs or photos with a self-addressed stamped envelope will be returned. Two artists sharing a space must each submit the required images. You will be notified of acceptance within a week of the May 7 deadline.

### EXHIBITION SPACE AND FEES

Booth spaces are 10' x 10'. Booth assignments are made to best serve the overall function of the festival. Assignments are made until all spaces are filled. Space assignments are final. Exhibitors may not reserve more than two spaces and must provide their own set-ups

(tables, chairs, tent weights, change, etc). Electricity is available in limited areas and may be requested for an additional \$10. Fees will be refunded to artists whose work is not accepted.

### SET-UP TIME

Beginning at 8:30 a.m. All vehicles must be cleared by 9:30. Vendors may park in the parking lot behind Bank of America.

### REGULATIONS

Exhibitors must remain for the duration of the show and have a representative on duty in the booth throughout the festival hours. Each artist is responsible for the display, protection, storing and removal of her/his work. DVAA will not be responsible for any loss of or damage to any work from any cause during the show. Artists should provide adequate protection for their work against sun, rain and wind. All tents and umbrellas must be weighed down and the all tents must be cleared from the street by 6:30 p.m.

### TAX

Collecting & paying New York State sales tax is the responsibility of the exhibitor.
